Historical Sketch

The University Interfaith Council is an umbrella organization which includes the Toledo Campus Ministry, Catholic Campus Ministry, Campus Christian Fellowship, Campus Crusade for Christ, Hillel, Interservice Christian Fellowship, Lifeline, Muslim Students Association, and the Newman Club. The council was founded in 1980 By Rev. Robert Kirtland, Judge James G. Carr, and Professor of Law Richard W. Edwards as a non-profit organization dedicated to charitable, religious and educational purposes. The mission of the council is to foster religious activities of all faiths, encourage the study of religion, promote religious understanding, and make religion a more meaningful force in the lives of faculty, staff and students at the University of Toledo.

The group has been active in a number of university related causes over the years, including a protest against Nation of Islam speaker Louis Farrakhan, and in creating the Raoul Wallenberg Scholarship for students.
